OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: The Tanger Outlet Centers' Back to School Sweepstakes (the "Sweepstakes") begins at 9:00 A.M. (Local time) on August 10, 2020 and ends at 11:59 P.M. (Local time) on August 30, 2020 (the "Sweepstakes Period").

ELIGIBILITY: The Sweepstakes is open only to individual legal residents of the fifty (50) United States and the District of Columbia who are at the age of majority at the time of entry. Void outside these geographic areas and wherever else prohibited by law. Employees, officers, directors and representatives of Tanger Management, LLC, Tanger Properties Limited Partnership, (D/B/A Tanger Outlet Centers) and their respective entities, affiliates and subsidiaries; employees, officers, directors, and representatives of stores located at Tanger Outlet Centers; and the immediate family (spouse, parents, siblings, and children) and household members of employees, officers, and directors of Tanger Management, LLC, Tanger Properties Limited Partnership, (D/B/A Tanger Outlet Centers) its affiliates and subsidiaries, and stores located at Tanger Outlet Centers, are not eligible. HOW TO ENTER: To enter the Sweepstakes an Entrant must post a photo of a great shopping find at a Tanger Outlet Center (no purchase required) to his/her personal Instagram® page or Twitter® account using **#TangerBTS2020**. An Entrant's Instagram® and Twitter® account must be set to a public setting in order for the Entry to be received and captured by Sponsor's platform. A purported Entry in which a photo is posted without the correct hashtag will be disqualified as incomplete. The workings of this Sweepstakes will be tracked through a Sponsor platform.

Sponsor will only accept entries during the Sweepstakes Period. An Entrant may enter the Sweepstakes only one (1) time and through only one (1) of the above described social media platforms during the Sweepstakes Period. Entrants are subject to all notices posted online including, but not limited to, Sponsor's Privacy Policy.

Potential winners will be required to show an appropriate and generally accepted form of identification. Entries become property of Sponsor and will not be acknowledged or returned. Following Tanger Outlets on Instagram® does not automatically indicate that the entry has complied with the Official Rules and may not be construed as an acceptance of the entry by the Sponsor. Sponsor reserves the right, in its sole and absolute discretion, to reject, disqualify and/or remove any entry without prior notice to the Entrant if, in Sponsor's sole opinion, the entry violates these Official Rules or the spirit of the Sweepstakes.

Gift cards may be used towards the purchase of merchandise at stores located within a Tanger Outlet Center in the United States. If a potential prize winner does not respond to Sponsor within the required time period, such potential winner may be disqualified, and an alternate winner will be selected by random drawing.
