OFFICIAL RULES

ELIGIBILITY: The Tanger Last Minute Gifting Sweepstakes (this "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia residents who are at least eighteen (18) years old or the age of majority in their state/country of residence at the time of entry. Duplicate or mechanically reproduced entries will not be accepted.
