OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. MANY WILL ENTER; One (1) WILL WIN.

SWEEPSTAKES PERIOD: Tanger's Tanger Club Sweepstakes (the "Sweepstakes") begins at 9:00 A.M. (Local Time) on July 21, 2026, and ends at 9:00 P.M. (Local Time) on August 9, 2026 (the "Sweepstakes Period").

ELIGIBILITY: Tanger's Sweepstakes is open only to Tanger Club Members who are legal residents of the fifty (50) United States (excluding Rhode Island) and the District of Columbia and 18 years or older at the time of entry. Void outside these geographic areas and wherever else prohibited by law. Employees, officers, directors and representatives of Tanger and their respective entities, affiliates and subsidiaries; employees officers directors and representatives of stores located at Tanger Centers; and the immediate family (spouse, parents, siblings, and children) and household members of employees, officers, and directors of Tanger and its affiliates and subsidiaries, and stores located at Tanger Centers, are not eligible. Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

HOW TO ENTER: No purchase to enter or win. During the Sweepstakes Period, eligible Tanger Club Members may enter the Sweepstakes by filling out and submitting the web-entry form made available through Tanger.com. The web-entry form will require the entrant's name and email address associated with the entrant's Tanger Club membership.

Limit one (1) entry per Tanger Club member during the Sweepstakes Period. Individuals may maintain only one Tanger Club membership. Duplicate or multiple entries associated with the same individual will be void.

Any attempt by any entrant to obtain more than the stated number of entries by using multiple identities or memberships will void all entrant's entries and may result in disqualification. All entries must be submitted and received during the Sweepstakes Period. Potential winners will be required to show an appropriate and generally accepted form of identification. Entries become property of Sponsor and will not be acknowledged or returned.
