OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. MANY WILL ENTER; TEN (10) WILL WIN.

SWEEPSTAKES PERIOD: Tanger®'s Tanger® Club Sweepstakes (the "Sweepstakes") begins at 9:00 A.M. (Local Time) on September 8, 2026, and ends at 9:00 P.M. (Local Time) on September 30, 2026 (the "Sweepstakes Period").

ELIGIBILITY: Tanger®'s Sweepstakes is open only to Tanger® Club Members who are legal residents of the fifty (50) United States (excluding Rhode Island) and the District of Columbia and 18 years or older at the time of entry. Void outside these geographic areas and wherever else prohibited by law. Employees, officers, directors and representatives of Tanger® and their respective entities, affiliates and subsidiaries; employees officers directors and representatives of stores located at Tanger® Centers; and the immediate family (spouse, parents, siblings, and children) and household members of employees, officers, and directors of Tanger® and its affiliates and subsidiaries, and stores located at Tanger® Centers, are not eligible. Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

HOW TO ENTER: No purchase necessary to enter or win. Eligible entrants may enter by any method permitted by these Official Rules. During the Sweepstakes Period, eligible entrants may enter by: (i) uploading a valid purchase receipt through their Tanger® Club account using the Tanger® app or other designated Tanger® Club receipt-upload platform; (ii) becoming a new paid TangerClub Gold member; or (iii) using the Alternate Method of Entry described below. Uploading a receipt, making a purchase, or becoming a paid TangerClub Gold member is not required to enter or win.

Alternate Method of Entry: To enter without uploading a receipt, making a purchase, or becoming a paid TangerClub Gold member, an eligible entrant may mail a handwritten postcard with their full name, email address associated with their Tanger® Club membership, and mailing address to: Tanger® Club Sweepstakes, 3200 Northline Avenue, Suite 360, Greensboro, NC 27408. Mail-in entries must be postmarked and received during the Sweepstakes Period to be eligible. Regardless of method of entry, all entries will have an equal chance of winning within the applicable prize drawing. To enter the New TangerClub Gold prize drawing by mail without becoming a paid TangerClub Gold member, entrant must clearly write "New TangerClub Gold Prize Drawing" on the postcard. Mail-in entries that do not designate a prize drawing will be entered into the prize drawing applicable to the entrant's TangerClub membership status as determined by Sponsor.

Limit one (1) entry per Tanger® Club member during the Sweepstakes Period, regardless of method of entry. Individuals may maintain only one Tanger® Club membership. Duplicate or multiple entries associated with the same individual will be void.

Any attempt by any entrant to obtain more than the stated number of entries by using multiple identities, memberships, or methods will void all entrant's entries and may result in disqualification. All entries must be submitted and received during the Sweepstakes Period. Potential winners will be required to show an appropriate and generally accepted form of identification. Entries become property of Sponsor and will not be acknowledged or returned.

Submission of an entry does not indicate that the entry has complied with the Official Rules and may not be

Use of the Tanger® App, uploading a receipt, or completing a qualifying credit card–linked transaction is not required to enter or win. No survey or feedback submission is required to participate in this Sweepstakes.

METHOD OF DETERMINING WINNER:

At the conclusion of the Sweepstakes Period, Sponsor will conduct separate random drawings from among all eligible entries properly and timely submitted and received for each applicable prize category.

Duplicate, incomplete, illegible, mechanically reproduced, or apparent fraudulent entries may be disqualified within Sponsor's sole discretion.

The winners need not be present to win. Potential winners will be selected and notified on or about September 30, 2026. Potential winners will be notified by email, either directly by Sponsor or through Sponsor's prize fulfillment provider, Giftogram®.
